## STATE ROAD A1A PARTICIPATES IN ITS FIRST FLORIDA SCENIC HIGHWAY DAY

It was a picturesque and scenic day as Broward County's State Road (SR) A1A partook in its first Florida Scenic Highway Day on Friday, March 26, 2010. The event took place at the Town of Lauderdale-By-The-Sea's Jarvis Hall, where the public was invited to meet and greet elected officials, members of the Broward County SR A1A Scenic Highway Corridor Advisory Group (CAG), and representatives from the nine cities along the highway.

Broward County Mayor and Broward MPO member Ken Keechl, Town of Lauderdale-By-The-Sea's Mayor Roseann Minnet, Vice Mayor Stuart Dodd, Commissioner Birute Ann Clottey, and the Town of Hillsboro Beach Commissioner Celinda Sawtelle were there to support the first Broward County Florida Scenic Highway Day celebration and share information on what this designation will mean for residents and visitors alike.

The public also had the opportunity to learn about the Florida Scenic Highways Program and get information on how they can become involved. The Florida Department of Transportation (FDOT) recently completed installation of signage that spotlights the official Florida Scenic Highways logo throughout the SR A1A corridor from the Broward/Palm Beach County Line to the Broward/Miami-Dade County Line, and at east/west bridge approaches and departures.

Broward County's designation is important as there are only 23 scenic highways in the state of Florida. The nine cities along the 28-mile SR A1A corridor from north to south are: Deerfield Beach, Town of Hillsboro Beach.

Pompano Beach, Town of Lauderdale-By-The-Sea, Sea Ranch Lakes, Fort Lauderdale, Dania Beach, Hollywood, and Hallandale Beach.

## Message from The Chair

On November 19. 2009, the Broward Metropolitan Planning Organization (Broward MPO) Board unani-

mously adopted its 2035 Long Range Transportation Plan (LRTP). The 2035 LRTP sets the framework for a balanced and forward thinking transportation system with investments in alternative modes such as mass transit and bicycle and pedestrian facilities. The Broward 2035 LRTP, branded as "Transformation," is the Broward MPO's transportation plan for change.

The first thing one may notice is our Broward MPO quarterly newsletter has a new name befitting of the new direction of the 2035 LRTP: TRANSPORTATION TRANS-FORMATION. More importantly, on March 11, 2010, the Broward MPO Board took the first step in creating a "structurally and institutionally" independent MPO. The Broward MPO unanimously voted to terminate the current Staffing Agreement with Broward County, effective no later than August 11, 2010.

In an effort to move forward, the Broward MPO will restructure its organization, develop innovative policies and procedures, and will partner with local government agencies, including Broward County, to provide the needed transformation of Broward County's transportation system. The Broward MPO's restructuring will allow our agency to become more competitive as a recipient of federal funding to implement premium transit service and associated bicycle and pedestrian facilities identified in the 2035 Transformation LRTP.

The upcoming Unified Planning Work Program (UPWP) is also undergoing a transformation consistent with the new direction of the Broward MPO.

Final approval of the UPWP is anticipated to occur at the May 13, 2010 Broward MPO meeting. In this issue we ask the public to provide feedback on the draft UPWP which is available for review. We welcome and encourage comments from the public, as we are here to serve the residents of Broward County.

#### **UPWP Dollars:** How Would You Spend IT?

The Broward MPO Unified Planning Work Program (UPWP) is a federally required document describing the transportation planning activities to be undertaken, including the description of transportation planning activities, with associated costs, to be accomplished in and for Broward County by the Broward MPO during the period of July 1, 2010-June 30, 2012.

The UPWP is comprised of four major areas:

Administration - This section includes activities required to manage the transportation planning process on an ongoing basis, including UPWP development and maintenance, and public involvement/education.

**Data Collection and Analysis** -Activities in this section include safety data collection, and Geographic Information Systems (GIS) capabilities development.

Program and Plan Development - Activities in this section include the Long Range Transportation Plan (LRTP), Transportation Improvement Program (TIP), and Bicycle and Pedestrian Mobility Planning.

Business Plan - Includes a five year projection for using annual Federal Highway Administration (FHWA) planning funds.

The DRAFT UPWP is available for comment until May 12, 2010. The Broward MPO will approve the Final UPWP on May 13, 2010.
