

City Managers and Local Officials,

This email is to notify you that the **2016 Complete Streets and Other Localized Initiatives Program has been formally announced.** The new Complete Streets and Other Localized Initiatives Program is a streamline program that will merge the Transportation Alternative Program (TAP) funding with additional MPO funding for mobility projects. The program can potentially fund mobility projects such as, but are not limited to, complete streets projects, traffic calming and intersection improvements, ADA upgrades, mobility hubs, bus shelters, bike racks and technology advancements such as transit signal priority and traffic control devices

Applications are now being accepted through January 15, 2016. The Complete Streets and Other Localized Initiatives project application maximum funding request accepted will be \$1.5 million per application, including design. A maximum of five (5) applications per applicant/municipality may be submitted. An additional five (5) partner applications (as defined in the Policies) may be submitted by applicant/municipality . Please see the attached Program Policies and Evaluation Criteria which defines “applications/partner applications” as well as other information. Applicants do not have to be Local Agency Program (LAP) certified as the FDOT will construct the project in coordination with the applicant and MPO staff.

Please note the **due date** to submit completed applications is **January 15, 2016 at 5pm**. Given this is a new Program, it is not advisable to wait to the last minute to submit completed applications.
